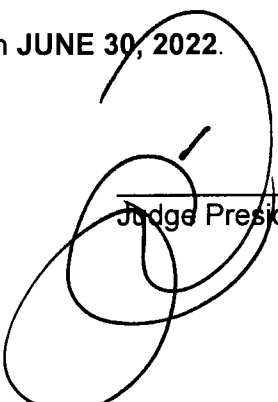
ORDER DISMISSING

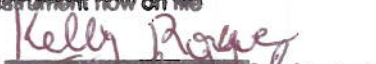
